Provides an acceptable, safe, serviceable, clean and attractive facility and surrounding grounds. May supervise subordinate employees.</p> <p>Minimum Qualifications (Agency Specific): High school diploma or GED and six (6) years of grounds maintenance experience with experience supervising or leading a crew and must have a valid Georgia Driver's License and meet the agency's requirements to be an authorized driver.</p> <p>Preferred Qualifications in addition to meeting minimum qualifications must possess one or more of the following (Agency Specific):</p> <ul style="list-style-type: none"> • Two (2) years of architectural design/landscape architecture experience. • One (1) year of experience providing commercial/professional grounds keeping/landscape services. <p>Competencies (Agency Specific): Excellent oral and written communication skills.
