## Call to order and approval of the December 2, 2020 meeting minutes.

Governor Kemp called the meeting of the Georgia Building Authority to order and stated the first order of business would be approval of the minutes of the December 2, 2020 meeting. Brad Raffensperger made a motion to approve the minutes and Kris Martins seconded the motion. The motion carried unanimously.

## Approve the proposed FY 2022 annual operating budget for the Georgia Building Authority.

April King presented the request to approve the FY 2022 annual operating budget. GBA budgeted conservatively in FY 2021 due to uncertainty how COVID would affect the authority. GBA worked with multiple agencies though out the year that have vacated space and were able to backfill tenants off capitol hill back into GBA buildings. There is an anticipated slight revenue growth for FY-22 of \$670,000 to be allocated between personal services and operating expenses for repairs and maintenance. During the current fiscal year, GBA has been able to take advantage of hiring temporary personnel from the World Congress Center and delayed hiring strategies but will expect to fill those position in FY-22.

Michael Howell motioned to approve the request and Brad Raffensperger seconded the motion. The motion carried unanimously.

# Request to approve the resolution for the sale of General Obligation Bonds for Georgia Building Authority projects.

April King presented the request to approve the resolution for two bond funded projects to be included in GSFIC GO Bond sale earlier today. GBA received appropriated funds in FY-22 in the amount of \$2.5 million for the renovation of Law Building, which will be used design and \$1.5 million for other improvements across capitol hill.

Steve McCoy motioned to approve the request and Brad Raffensperger seconded the motion. The motion carried unanimously.

Governor Kemp requested a motion for adjournment. So moved by Jay Lin and seconded by Brad Raffensperger. Meeting adjourned.
