## Department of Public Safety

The Department of Public Safety (DPS), which includes the Capitol Police Division and the Georgia State Patrol, provides security to all GBA facilities on Capitol Hill. DPS has established a patrol post and police department (Post 50) on Capitol Hill located at 180 Central Avenue.

*To report a crime, suspicious activity, emergencies, or if you need assistance, please call 404-624-7281.*

DPS has primary responsibility during an emergency or crisis and may order the evacuation of a building when there is evidence that there is a grave risk to life or property within a particular building.

## State Fire Marshal

Office of Insurance and Safety Fire Commissioner

All buildings owned, operated, or occupied by the State are subject to fire safety inspections by the State Fire Marshal's Office. State inspectors are given the authority to determine whether the life safety of the occupants and the general public is in danger from fire, explosion, or related hazards, and to enforce requirements set forth by law (OCGA 25-2-22). The Fire Marshal's Office is charged with determining if the level of safety of each building is acceptable through a combination of prevention, protection, egress, and accessibility, which are established as a state minimum fire safety standard by the Safety Fire Commissioner.

## Entrances

The south entrance located on Capitol Square is accessible. The building is open from 8:00 a.m.-5:00 p.m. Monday-Friday, except for State holidays.

## Inside the Capitol

The House and Senate galleries located on the 4th floor each have accessible seating areas. There are committee meeting and conference rooms available throughout the building. For specific information on accessibility for the Senate gallery and committee rooms, contact the Secretary of the Senate's office at 404-656-5040; for the House gallery and committee rooms, contact the Clerk's Office at 404-656-5015.

## Courtesy Wheelchair and Scooter Availability

Courtesy wheelchairs and scooters are available on a first-come, first-served basis at the south entrance located on Capitol Square. Three wheelchairs and two scooters are available. Photo ID is required. Wheelchairs and scooters must remain on Capitol property at all times.

## Restrooms

There is an accessible single user restroom on the first floor near the east entrance. A designated women's restroom is located on the second floor, in room 233. A designated men's rest room is located on the fourth floor, adjacent to the House gallery, in room 425.

## ADA Accommodation Requests

Sign language interpreting services are available for:

- meetings with legislators,
- legislative committee hearings,
- House and Senate floor sessions, and
- guided Capitol tours (see Helpful Resources, p. 10).

## Assistive Listening Systems

Assistive listening devices are available for use in the galleries. The systems, for the exclusive use of people who have hearing loss, are available for the duration of a particular session or meeting and must be returned immediately following the session or meeting. Receivers may be signed out from room 323. Call 404-656-0445 for further information.

## Visitors with Visual Disabilities

Permanent room spaces, including House and Senate galleries, offices, hearing rooms and restrooms are designated using braille numerals with white-on-red signage. House personnel are available to assist individuals who need or desire further guidance. In addition, all elevators are equipped with audio floor notification and braille controls.



# PAUL D. COVERDELL LEGISLATIVE OFFICE BUILDING



## Entrance

The public entrance to the Paul D. Coverdell Legislative Office Building is accessible via a ramp located in the front of the building, off of Capitol Square, adjacent to the main entrance. The building is open from 7:00 a.m. - 5:00 p.m. Monday-Friday, except for state holidays.

## Restrooms

There are two sets of men’s and women’s restrooms with 38” wide toilet stalls and 32” clear opening out-swinging doors on each floor. If utilizing Cafe 244, there is an accessible restroom located between the men’s and women’s restrooms.

## Assistive Listening Systems

## Visitors with Visual Disabilities

Permanent room spaces, including House and Senate member offices, hearing rooms, and restrooms are designated using braille numerals with white-on-red signage. Personnel are available to assist individuals who need or desire further guidance. In addition, all elevators are equipped with audio floor notification and braille controls.





## Entrances

All public entrances to the Sloppy Floyd Building are accessible.

### Entrance when using MARTA

The James H. "Sloppy" Floyd Building is located above the Georgia State Marta train station. The Georgia State Marta train station is located on the blue/green line. When at the Georgia State Marta station take the stairs, escalator, or elevator up to the State Building. The security guard post will require a valid photo I.D. to access the State Building and the East or West Tower upper floors.

### Entrance when Parking

Once parked in the Pete Hackney parking deck, take the elevator or stairs to the 5th level of the parking deck which has the entrance to the pedestrian bridge. The pedestrian bridge will take you into the Butler parking deck. Once in the Butler parking deck, take the elevator or stairs to the 3rd level (Bridge). Take the bridge into the Floyd building. You will enter the Floyd building via the East Tower balcony level. The security guard post will require a valid photo I.D. to access the building floors. The Pete Hackney parking deck is located at 162 Jesse Hill Jr. Drive SE, Atlanta, GA 30303.



## Restrooms

There is an accessible single user restroom on the cafeteria level across the hall from the East Tower stairs. Additionally, there are restrooms designated as accessible in the East Tower on floors 12, 16, and 20, and in the West Tower on floors 4, 8, 12, 16, and 20.

## Capitol Commons Café

The Café is located on the bottom level of the building. There are elevators in both the East and West Towers that provide access to the cafeteria level.



# TRANSPORTATION



## MARTA

The Georgia State Capitol building is less than one block away from the Georgia State MARTA Station on the blue/green rail line. If you are coming from the red or gold rail line, exit at the Five Points Station and follow the signs to the Eastbound platform. Get on the eastbound train and ride one stop to the Georgia State Station. Take the Piedmont Avenue exit out of the station and turn left on Piedmont Avenue. The Capitol is located less than one block south of the MARTA station.

## Public Parking for State Capitol Visitors

Parking for visitors to Capitol Hill is available for a daily fee at the following parking facilities:

- Steve Polk Parking Lot on Martin Luther King Jr. Drive. 65 MLK, Jr. Drive SW, Atlanta, GA 30334
- Pete Hackney at the corner of Decatur Street and Jesse Hill Jr. Drive. 162 Jesse Hill Jr. Drive SE, Atlanta, GA 30303
- Capitol Lot Daily public parking is across from the State Capitol and next to Liberty Plaza going south. 218 Capitol Avenue, Atlanta, GA 30334



These parking facilities all have designated accessible parking. For more information, contact the Georgia Building Authority (GBA) Parking Services at 404-656-3251.

Additional parking is available in privately operated facilities dispersed in the area.

*Descriptive/directional signs on the Capitol grounds indicate accessible routes. Voice signals for directional orientation are located at the crosswalks on Capitol Hill.*

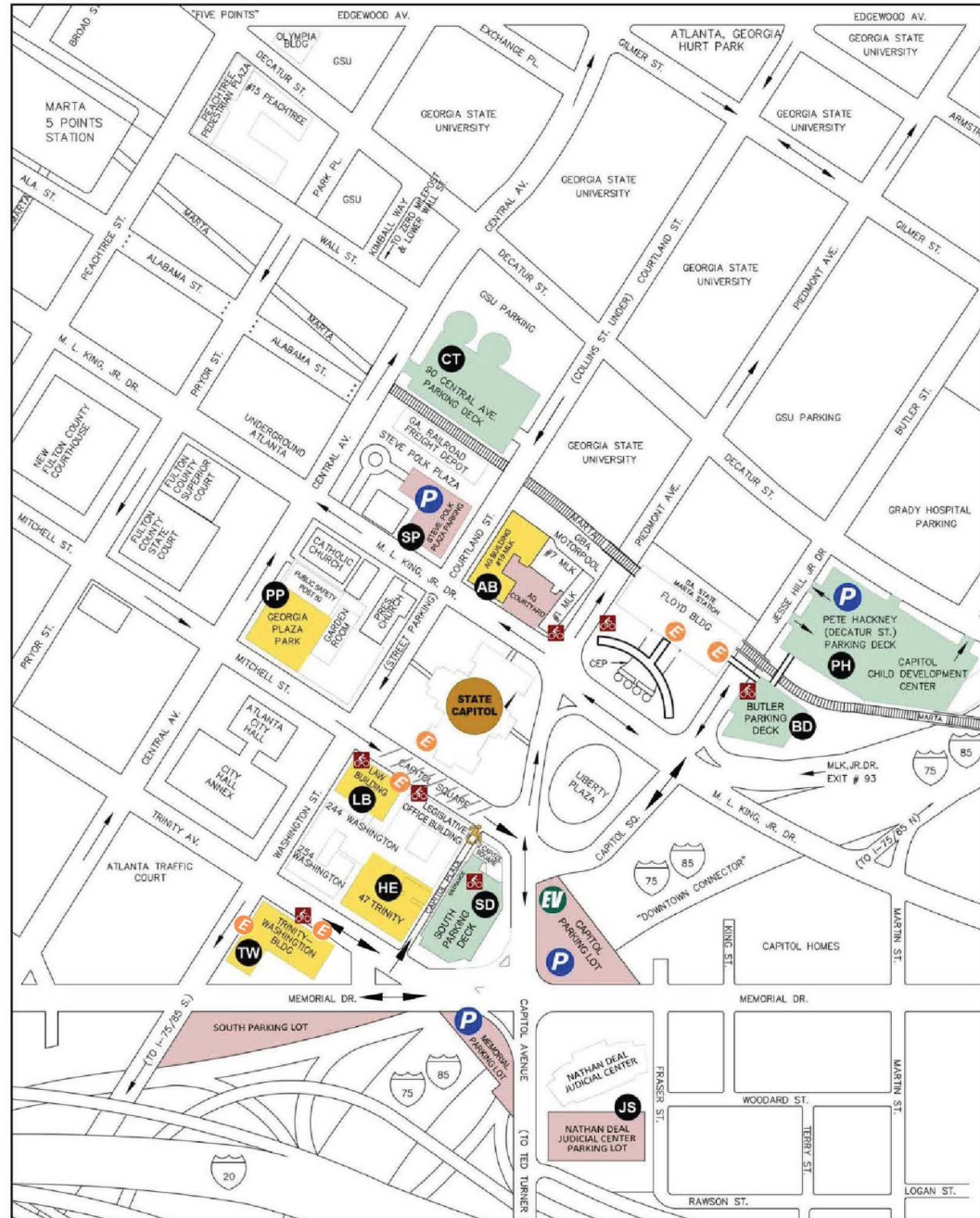
