<p><u>Position Description:</u></p> <p>The Leasing Specialist II (LS II) is responsible for the management of activities related to an assigned portion of the total portfolio of approximately 1,200 existing leases. The portfolio consists of both large and small commercial leases (under 1,000 to over 100,000 square feet).
