# **GBA PROCUREMENT**

All procurement activity required by the Georgia Building Authority (GBA) is managed by the Procurement Services Department located at One Martin Luther King, Jr. Drive in Atlanta, Georgia.

Requirements are posted to the Georgia Procurement Registry (GPR) website at http://ssl.doas.state.ga.us/PRSapp/PR\_index.jsp. GBA does not maintain a separate bidders' list. All qualified bidders or proposers must respond to posted requirements in the manner prescribed and by the appropriate time listed on the solicitation announcement found in said GPR.

## **TYPES OF SOLICITATIONS**

There are generally two types of solicitations that are issued by the GBA Procurement Services Department.

- Invitations to Bid (ITB) Results in a priced non-negotiable response.
- Request for Qualified Contractors

   (RFQC) / Request for Proposal (RFP) –
   Results in the collection of Statements of
   Qualifications and the submittal of proposals
   from the initial respondents deemed to be
   the most qualified to proceed into further
   evaluation and if chosen, negotiations.

Sometimes you will also see RFI, RFQ or ITN as designations. Consult our Procurement Staff concerning these.
